



Fee waivers may be discontinued in whole or in part after that date. The Adviser has also contractually agreed to reimburse expenses as necessary to limit total annualized expenses, other than certain excluded expenses, of the Portfolios to 0.15% (for ELUSX and ELSMX), 0.05% (for EYUSX, EYSMX), 0.20% (for ELINX, ELISX and ELMMX), and 0.10% (EYINX, EYISX, EYMMX) for the period from September 28, 2018 through September 30, 2020. Expense reimbursement may be discontinued in whole or in part after that date. In the absence of fee waivers and reimbursements, returns for the Portfolios would have been lower.

The tax treatment of certain of the Portfolio's investments under one or more of the qualification or distribution tests applicable to RICs is not certain. An adverse determination or future guidance by the IRS might affect the Portfolio's ability to qualify for such treatment.

If, in any year, the Portfolio were to fail to qualify as a RIC under the Code for any reason, and were not able to cure such failure, the Portfolio would be subject to tax on its taxable income at corporate rates, and all distributions from earnings and profits, including any distributions of net tax-exempt income and net long-term capital gains, would be taxable to shareholders as ordinary income.

The Portfolio is classified as non-diversified under the 1940 Act. Accordingly, the Portfolio may invest a greater portion of its assets in the securities of a single issuer than if it were a diversified fund, which may subject the Portfolio to a higher degree of risk associated with and developments affecting that issuer than a fund that invests more widely. The Portfolio is an open-end management investment company.

Price-to-Earnings Ratio (P/E) is ratio of a company's current share price to its earnings per share. P/E Ratio excludes companies with negative earnings. Return on Equity (ROE) is ratio of a company's earnings to its shareholders' equity. RIY is Russell 1000 Index, an index of 1000 large capitalization US stocks.
